## **Volunteer Training - Goshen County Task Force on Family Violence & Sexual Assault**

**Torrington: Monday night classes at EWC Community Training Center (training sites for other days noted on calendar – *calendar and narrative attached*)**

If you are interested in learning about the issues of family violence and sexual assault, or becoming a program volunteer, this course is for you. The free 40-hour training begins with two sessions on domestic violence, followed by a session on disabilities and elder abuse taught by Ginny Chidsey with the Division of Victim Services. This will be followed by a daylong Saturday session on sexual assault. Individual sessions will be taught on child abuse, stalking, the legal process, filing victim compensation claims, and advocacy. Classes will meet eight Monday evenings January 28 through March 10 (excluding Feb. 18) from 5:30-8:30 at the Community Training Center; two Saturdays from 9 a.m. to 5 p.m. on Feb. 16 and Mar. 8 at alternate locations; and one afternoon session noon to 5 p.m. at the Goshen County Courthouse on Feb. 26. All class materials are provided, so please pre-register. You may attend individual sessions.
